**Sub. : Sanction of Additional dose of Dearness Relief (T.I.) @11% on Pension/  
Family Pension w.e.f. 01.07.2021.**

In pursuance of Finance Department, Govt. of Odisha Office Memorandum No. Fin-CS3-PEN-0002-2020-28447/F dt. 08.10.2021 in respect of enhancement of "Dearness Relief (TI)" on Pension /Family Pension @ 11% w.e.f. 01.07.2021, the management of OPTCL is pleased to adopt the same in favor of OPTCL Pensioners/Family Pensioners.

Accordingly, the additional dose of Dearness Relief (TI) on Pension shall be paid to the Pensioners/Family Pensioners of OPTCL at the rate of 11% on the revised Basic Pension/Family Pension w.e.f. 01.07.2021. With sanction of this Dearness Relief (TI) of 11%, the Dearness Relief (TI) is hereby enhanced from 17% to 28% w.e.f. 01.07.2021.
