CIRCULAR

Government of Odisha ,Finance Department have issued office memorandum No23420 dated 18.08.2020 regarding special arrangement for disbursement of pension/family pension during the situation arising out of the spread of Covid-19 .

Accordingly, in line with the above Office Memorandum of Finance Department , the management of Gridco Pension Trust has been pleased to adopt the said changes in the existing pension disbursement process for all pensioners/Family pensioners drawing Pension from Gridco Pension Trust .The following guidelines may be followed :-

SI No	Subject	Modification/Relaxation
1	Periodical Identification of the Pensioners (Submission of Annual Life Certificate)	The requirement of submission of annual life certificate for the year 2020(Submited during the month of November) by the pensioners/family pensioners is extended for six months i.e. up to May 2021 .
2	Submission of re-marriage Certificate	The requirement for submission of non-marriage/re-marriage declaration to the D.D.O. for the year 2020 is extended for six months i.e. up to May 2021 .
3	Submission of non-employment Certificate	The requirement for submission of non-employment certificate to the D.D.O. for the year 2020 is extended for six months i.e. up to May 2021 .
4	Disbursement of pension for the first time suo-moto by the D.D.O. without the physical appearance of the pensioner.	At the first time of payment of pension, the appearance of the pensioner is not essential during the current period of COVID-19 ,pandemic.


