Sub: Sanction of Additional dose of Dearness Allowance @ 6% w.e.f. 01.01.2016.

In pursuance of Finance Department, Govt. of Odisha Office Memorandum No. Fin-CS-II(ALW)-0002/2016- 13362/F dt. 30.04.2016, the management has been pleased to release additional dose of D.A. @ 6% on the Basic Pay and grade pay taken together w.e.f. 01.01.2016 for the employees / workers of OPTCL on the revised pay structure. With this sanction of additional dose of D.A. of 6% w.e.f. 01.01.2016, the D.A. now payable will be enhanced from 119% to 125% on the Basic Pay & Grade Pay in the revised scale of pay.

2. Government Officers working on deputation terms with OPTCL shall be paid the increased dose of D.A as per the rules notified in Finance Department Office Memorandum No. Fin-CS-II(ALW)- 0002/2016- 13362/F dt. 30.04.2016.

3. This additional dose of D.A will be drawn in the Pay Bill of May,2016 payable in June,2016 and onwards. The Arrear D.A amount for the period from January,2016 to April,2016 shall not be drawn before the date of disbursement of salary of May,2016.

4. The increased additional dose of D.A in accordance with this Order, will also be admissible to the employees / workers who were in service as on 1<sup>st</sup> January,2016 but have ceased to be in service at the time of sanction of this enhanced D.A.

5. The additional dose of D.A may also be paid to the Work-charged Employees w.e.f. 01.01.2016.

This is subject to post-facto approval of the BoD.
