Sub. : Sanction of Additional dose of Dearness Allowance @11% w.e.f. 01.07.2021.

In pursuance of Finance Department, Govt. of Odisha Office Memorandum No. Fin-CS2-ALW-0017-2019 No. 28337/F dt. 08.10.2021 the management of OPTCL is pleased to release additional dose of Dearness Allowance @ 11% on the Basic Pay w.e.f. 01.07.2021 for the employees of OPTCL on the revised pay structure. With this sanction of additional dose of Dearness Allowance @ 11%, the Dearness Allowance now payable is enhanced from 17% to 28%.

2. Government Officers working on deputation terms with OPTCL shall be paid the increased dose of Dearness Allowance as per the rules notified in Finance Department Office Memorandum No. Fin-CS2-ALW-0017-2019 No. 28337/F dt. 08.10.2021.

3. This additional dose of Dearness Allowance will be paid in cash and can be drawn in the Pay Bill of October, 2021 and onwards. The payment of Arrear Dearness Allowance of July, 2021 to September, 2021 on account of enhanced Dearness Allowance shall be drawn and disbursed after drawal of salary of October, 2021.

4. The increased additional dose of Dearness Allowance in accordance with this order, will also be admissible to the employees who were in service as on 1st July, 2021 but have ceased to be in service at the time of sanction of this enhanced Dearness Allowance.
