ORDER

Subject: Functioning of Government Offices with effect from 16th July, 2021.

All Departments of the State Government and Sub-ordinate Offices in the State shall function with full strength of employees with effect from 16th July, 2021 until further orders. Most of the employees are now fully vaccinated and are required mandatorily to attend office regularly. In case any employee has been unable to get vaccinated for medical or some other compelling reason(s), s/he must apply for an exemption to the Head of Office. On receipt of such application, the matter can be considered on a case-to-case basis. Employees who are neither vaccinated nor exempted would not be permitted to attend office w.e.f 16th July, 2021 and their absence will be treated as wilful.

All State Government Offices shall remain closed on Saturdays.


All precautionary measures indicated in Letter No. 13365/Gen Dt. 08.06.2020 issued by this Department to prevent spread of COVID infection shall be strictly followed by all the Offices as well as the employees. In case of detection of COVID infection case in any Office, the protocol issued vide Letter No. 17290 Dt. 23.07.2020 of this Department shall be followed and be reported to concerned Head of Office, forthwith.


