OFFICE ORDER

Consequent upon approval by Board of Directors of OPTCL in its 94th meeting held on 19.03.2018 for revision of Pension / Family Pension of Pre-2016 and Post-2016 Pensioners / Family Pensioners by adopting the principles for revision of pension/ family Pension, gratuity and commuted value of pension provided in Finance Dept. Office Memorandum No. 28300 dated 23.09.2017, Office Order No 13377 dated 21.06.2018 has been issued for revision of pension/ family pension of Pre-2016 and Post-2016 pensioners of OPTCL. However, Govt. in Department of Energy have notified for grant of Differential Pension in respect of Govt Cadre employees deputed to the Corporation and absorbed thereon vide Notification No. 499 dated 20.01.2016. That Revision of Differential Pension consequent to future revision of pay shall be done by the Transferee organisation only after the revision of Pension made at Government level.

Therefore such pensioners are hereby requested to submit their application and undertaking in the prescribed format (enclosed) along with attested copies of the revised PPOs of the Government/ Bank statement regarding receipt of revised pension and T.I. to Sr. GM (HRD) Pension for revision of differential pension.
