CIRCULAR

The 73rd Republic Day is going to be celebrated on 26th January, 2022 which shall commemorate the process of establishment of the Indian Constitution. To mark the occasion, various online competitions are being organized among the employees of OPTCL and GRIDCO and their family members. All are requested to participate in the competition in large numbers.

The details of the competition are as follows:

ESSAY COMPETITION

Category I:

- All the employees of OPTCL and GRIDCO below 35 years can participate in this competition.
- The topic of essay is "What is the meaning of freedom according to the youth of India".
- Word limit is 500 words. The essay should be typed in Times New Roman font, size 12 with 1.5 line spacing. The essay must be submitted in .jpg or .png or .jpeg format only.
- The upload size of the photo should not exceed 10 MB. One can upload multiple photos depending on the number of pages.

Category II:

- All the employees' children of OPTCL and GRIDCO in the age group 10 -18 years can participate in this competition.
- The topic of essay is "Together we can".
- Word limit is 200 words. The essay should be handwritten. The essay must be submitted in .jpg or .png or .jpeg format only.
- The upload size of the essay should not exceed 10 MB.

DRAWING COMPETITION

Category I:

- All the employees of OPTCL and GRIDCO can participate in this competition.
- The theme of the drawing competition is "History and Heritage".
- The drawing/painting must be submitted in .jpg or .png or .jpeg format only.
- The upload size of the drawing/painting should not exceed 10 MB.

Category II:

- Children of employees in the age group 7 – 12 years (Group 1) and 13-18 years (Group 2) are eligible to participate.
- The theme of the drawing competition is “**Republic Day celebration in school**” for Group 1 and “**Unity in diversity**” for Group 2.
- The drawing/painting must be submitted in .jpg or .png or .jpeg format only.
- The upload size of the painting/drawing should not exceed 10 MB.

CRAFT COMPETITION

- All the employees’ children of OPTCL and GRIDCO in the age group 10 -18 years can participate in this competition.
- The theme of the competition is “**Best from waste**”.
- The photo of the craft must be submitted in .jpg or .png or .jpeg format only.
- The upload size of the craft should not exceed 10 MB.

COOKING COMPETITION

- All women employees and spouses of male employees can participate in the competition.
- The theme of the competition is - Tri Colour. The dish should represent the colours of the Indian Flag.
- Marks will be awarded for visual appeal also.
- A short video of preparation of the dish (max. 30 seconds) and photo of the dish must be submitted in .jpg or .png or .jpeg format only should be uploaded along with recipe of the dish.
- The upload size of the photo should not exceed 10 MB.

FANCY DRESS COMPETITION

- Children of employees are eligible to participate. Maximum age limit is 18 years.
- The theme of the fancy dress competition is “**Patriot**”.
- A short video of (max. 30 seconds) with the child dressed up as famous political personality of India along with short speech of the personality to be submitted. A photo also must be submitted in .jpg or .png or .jpeg format.
- The upload size of the photo should not exceed 10 MB.

INSTRUCTIONS:

- The last date for receipt of entries is **31st January 2022**.
- Result will be declared on **14th February 2022**.
- The photo and video should be uploaded in the OPTCL website. The activated link to register and upload the documents, images, audio and video will be provided on **28th January 2022, 11 a.m** at OPTCL website.
